Literature on cooperative federalism (Saxena, 2018) and competitive federalism (Dhar, 2016) provides theoretical grounding for analyzing Sarma's interaction with the central government and other states.

Gap in Existing Literature

Despite growing scholarly interest in regional leadership in India, there exists a significant gap in academic literature regarding the systematic analysis of leadership emerging from Northeastern states, particularly Assam. This research addresses this gap by providing an in-depth analysis of Sarma's leadership model and its implications for both regional development and national politics.

Innovative Governance Approach: District-wise Assembly Sessions

Analysis of media coverage and public response to these district sessions indicates positive reception, with increased citizen engagement and greater visibility for local issues in legislative deliberations (Roy, 2023). This approach aligns with theoretical frameworks of deliberative democracy and participatory governance, representing an innovative adaptation of traditional democratic institutions to address regional governance challenges.

KEY POLICY INITIATIVES AND GOVERNANCE IMPACT

Economic Development and Fiscal Management
