His fifteen-year ministerial experience equipped him with comprehensive knowledge of state administration and policy implementation. During this period, he demonstrated notable administrative competence, particularly in health sector reforms and educational initiatives, establishing a reputation for administrative efficiency and policy innovation.

Political Realignment and Strategic Leadership

Sarma's transition from the Indian National Congress to the Bharatiya Janata Party (BJP) in 2015 marked a pivotal moment in Assam's political history. This political realignment demonstrated Sarma's strategic foresight and ability to anticipate broader political shifts. The success of this strategic repositioning was evident in the 2016 Assam Assembly elections, where Sarma played a pivotal role in securing BJP's first-ever government in the state.

His appointment as convenor of the North-East Democratic Alliance (NEDA)—a BJP-led coalition of regional parties—institutionalized his role as the architect of the party's regional strategy. Under Sarma's strategic guidance,

BJP dramatically expanded its footprint across Northeast India, transforming the region from a Congress stronghold to one with significant BJP presence.

GOVERNANCE APPROACH AND POLICY INNOVATIONS

Sarma's governance philosophy centers on what can be termed "Pragmatic Developmentalism"—combining ambitious development goals with practical implementation strategies. His administration has prioritized:

Atmanirbhar Assam: A framework of policies aimed at promoting self-reliance through support for local industries, skill development, and entrepreneurship, with special provisions for traditional crafts, agricultural processing, and technology startups.

Investment Attraction Strategy: Implementation of a single-window clearance system for industrial investments, coupled with targeted incentives for priority sectors, resulting in investment commitments totaling approximately ₹79,000 crores during investment summits held in 2022 and 2023.

Infrastructure Development Push: Significant investments in transportation networks, including expansion of highways, bridges, and rural connectivity projects, with the state initiating construction of over 2,000 bridges and 15,000 kilometers of rural roads since 2021.

Social Welfare Innovations

Sarma's administration has implemented several innovative social welfare programs:

Orunodoi Scheme: A direct benefit transfer program providing monthly financial assistance to over 20 lakh economically vulnerable families, with women as the primary beneficiaries, credited with reducing extreme poverty and enhancing women's financial agency.

Mission Basundhara: A comprehensive land rights and documentation reform program that has streamlined property registration, reduced bureaucratic delays, and addressed longstanding land-related disputes, processing over 8.5 lakh applications.

Mission for Overall Improvement of Education (MOIE): A comprehensive education reform initiative including infrastructure upgradation, teacher training, curriculum modernization, and technology integration, associated with improved educational outcomes.

Health Infrastructure Expansion: Significant investments in healthcare infrastructure, including the establishment of new medical colleges, expansion of district hospitals, and modernization of primary health centers, improving healthcare accessibility in underserved regions.

LEADERSHIP STYLE AND ADMINISTRATIVE APPROACH

This capability was particularly evident during the COVID-19 pandemic, when Assam implemented one of the more effective pandemic management protocols among Indian

states, maintaining a case fatality rate significantly below the national average throughout the pandemic.

Protection of Indigenous Rights and Identity

A significant aspect of Sarma's governance has been his focus on protecting and advancing the rights of indigenous communities in Assam:
